



BINFORD SUPPLY, LLC ("MANUFACTURER") WARRANTS:

- 1. The limited warranty covers chain link fence fabric made from Class IV (1.2oz./ft.2) zinc coated wire. Manufacturer specially warrants:
 - A. That the wire used in the manufacture of this product meets the specifications set forth by the American Society for Testing and Material (ASTM) A817-91 for Type II Class 1 zinc coated steel wire, AASHTO digitation M181-86 for Type 1 Class C: and
 - B. That the Fence Fabric is guaranteed for a period of fifteen years against failure resulting from natural red rust or corrosion under normal light commercial or residential conditions. Failure is defined as structural failure of the wire resulting in loss of specific tensile strength or fracture of the wire.

IN NO EVENT WILL THE MANUFACTURER BE LIABLE FOR:

- Damage resulting from abnormal use, abuse, neglect, fire, flood, accident or Act of God.
- Accelerated corrosion resulting from atmospheres or abnormally harsh environments such as: chemicals, salt spray, animal waste and other known or unknown chemical or organic corrosives.
- The cost of installation, removal or re-installation of this product.
- 2. FOR BREACH OF ANY WRITTEN OR IMPLIED WARRANTY ON THIS PRODUCT, THE PURCHASER IS LIMITED TO THE FOLLOWING DAMAGES: repair or replacement cost as stated in paragraph 5 below. NOTE; SOME STATES DO NOT ALLOW THE EXCULSION OR LIMITATION OF INCIDENTAL OR CONSEEQUENTAL DAMAGES. SO THE ABOVE LIMITATION OR EXCLUSION MAY NOT APPLY TO YOU.
- 3. This limited warranty extends exclusively to the original purchaser of the warranted product. The term of this warranty begins on the original date of purchase by the purchaser and continues for a period of fifteen years.
- 4. In the event of defect, or other failure of the product not caused by any misuse or damage to the product while in the possession of the purchaser, the Manufacture will remedy the failure or defect, without charge to the purchaser, within 60 days. The remedy will consist of repair or replacement of the product, or refund of the purchase price, at the Warrantor's option. However, the Warrantor will not elect refund unless it is unable to provide replacement, and repair is not commercially practicable or cannot be made with the time for performance.
- 5. If this product or one of its component parts contains defect or malfunction, the purchaser shall notify Manufacturer in writing at P.O. Box 800607 Balch Springs, TX. 75180, describing the defect or malfunction and providing copies of the original sales receipt and tag from the defective or malfunctioning fabric. After a reasonable number of attempts by the Manufacturer to remedy the defect or malfunction, the purchaser is entitled to either a refund or replacement of the product claimed to be defective. Before the purchaser is entitled to the remedies referred to herein for breach of warranty, the Manufacturer must determine to its satisfaction the product is (a) Product made by the Manufacturer; and (b) defective.
- 6. As a condition to enforcement of this limited warranty, to obtain performance of any obligation under this warranty, the purchaser shall:
 - A. Complete the pre-addressed Warranty Registration card and return it to Binford Supply, LLC.
 - B. Keep the original sales receipt/invoice for proof of purchase
- 7. This limited warranty gives you specific legal rights, and you may also have other rights that vary from state to state.

THIS LIMITED WARRANTY IS IN LIEU OF ALL OTHER WARRANTIES, EXPIRED OR IMPLIED BY LAW, INCLUDING TH IMPLIES WARRANTY OF MERCHANTABILITY.
